# TUITION, FEES, ASSISTANCE, AND AWARDS

## TUITION & FEES

All families are *required* to register through FACTS Tuition Management (payment plan provider).

**Tuition: \$4,900**

**Fees: \$350 (non-refundable)**

Fees cover technology, textbooks, and admission to all games/plays/musical performances

## TUITION ASSISTANCE

All families interested in tuition assistance *or* need-based scholarships are required to submit an online application to the FACTS Grant & Aid Assessment.

The cost of submitting this application is \$40.00 and it ***must be submitted by April 21, 2023.***

FACTS **will not** process your application until all information is received. You will be notified by FACTS if they need additional information. You will be notified by mid-June regarding any tuition assistance.

## TUITION AWARDS

Some RCHS Scholarships require a specific application, essay, or letter of recommendation; each of these required documents must be turned in to the Development Office by April 21, 2023 in order to be considered eligible. When determining the eligibility for need-based scholarships, RCHS uses the results of the FACTS Grant & Aid Assessment.
